Constitution of Mount Saint Vincent University Christian Fellowship

Article 1: Name

The name of this organization is Mount Saint Vincent University Christian Fellowship (MSVUCF).

Article 2: Objectives

- To create a non-denominational assembly of Christ-focused Believers
- To promote love and support among its members and the community
- To provide a safe space for fellowship and building our faith based on Bible scriptures.
- To equip members with the knowledge needed to enhance their Christian development through the study, prayers, and discipleship.
- To love, care, and share the love of GOD in us.

Article 3: Membership

- 1. All Mount Saint Vincent University students, regardless of affiliation or religious denomination are eligible to become members of MSVUCF.
- 2. A student shall be considered an active member if they attend at least one meeting per semester virtually or in person.

Article 4: Membership Fees or Due

Membership does not require fees or dues to be paid as part of enrollment. Membership approval is subject to review and endorsement by the executive leadership on an annual basis.

Article 5: Executive Officers

The Executive Committee shall conduct leadership and oversight functions of the general membership and all standing committees.

The Executive Committee shall consist of the following positions: Vice President, Treasurer, Administrative Secretary, and Welfare & Discipleship Team Lead. President,

Article 6: Duties:

President: *This position is an Elevated position, so remains vacant until unanimously agreed by a majority of the members

- 1. Provides overall leadership and spiritual oversight to the society.
- 2. Chairs all executive and general meetings.
- 3. Represent the society in official capacities both within and outside the university.
- 4. Ensures the society stays true to its Christian vision and values.
- 5. Supervises and supports all executive officers.
- 6. Liaise with the MSVUSU and other relevant bodies when necessary.

Vice-President:

- 1. Supports the President and acts as the chair of the society in the absence of the President is not available.
 - 2. Designs and distributes promotional materials for events.
 - 3. Participates in public events and engaging with new members
 - 4. Liaises with the MSVUSU and other relevant bodies when necessary.

Treasurer:

- 1. Manages all financial records and transactions of the society, including the bank account.
- 2. Prepares and present budgets and financial reports when needed, but at least once a year.
- 3. Ensures accountability in the use of funds.
- 4. Liaises with the MSVUSU and other relevant bodies when necessary.

Administrative secretary:

- 1. Maintains a database of members and attendance records
- 2. Follows up with new membership.
- 3. Carries out administrative and secretarial functions
- 4. Coordinates records of monetary support from MSVUSU.
- 5. Coordinates logistical needs when planning an event.

Welfare & Discipleship Team Lead:

- 1. Plans and coordinates outreaches and events
- 2. Trains and encourages members in personal evangelism.

- 3. Collaborates with other campus ministries for events.
- 4. Follow up with new members towards establishing them.
- 5. Welfare support to members.
- 6. Develop and oversee the study and prayer sessions.
- 7. Encourage membership growth and understanding.

Article 7: Elections

- 1. Election of Executive Committee members shall take place before the last day of the preceding academic year.
- 2. All active members of the MSVUCF shall be informed of the date of the election of Executive Committee members.
- 3. Any active member of the MSVUCF can seek election to the Executive Committee.
- 4. Each active member of MSVUCF Society shall cast one vote for each position during the election of Executive Committee members.
- 5. The winner of the election shall be determined by majority vote.

Article 8: Meetings

MSVUCF shall have a general meeting or event at least once per semester which will be communicated via e-mails and text messages. Subject to review by resolution of the members.

Article 9: Impeachment of Officers

Executive Committee members shall hold office for a period of one academic year, beginning and ending the day after Executive Committee elections have been completed.

If Executive Committee members are not fulfilling requirements stipulated in their respective job descriptions, a majority vote of the active members shall constitute impeachment.

Article 10: Finance and Audit

- 1. Funds of the MSVUCF shall come from Students' Union, free will donations by members and other external sources (individuals and organizations).
- 2. The signing officers of the MSVUCF shall be the Treasurer and President. In the absence of the President, a designated Officer shall be appointed by a vote of the members.
- 3. The fiscal period of the MSVUCF shall be the academic year.

Article 11: Property

All surplus monies and all property purchased by the MSVUCF shall be carried over to the incoming executive committee each year.

Article 12: Constitutional Amendment

- 1. The Constitution shall become effective upon approval by a majority (fifty per cent plus one) of the Executive Committee.
- 2. Hereinafter, this Constitution may be amended at a meeting of the general membership by a two-thirds majority vote of the Executive Committee.
- 3. Proposed amendments must be submitted in writing.
- 4. The effectiveness of this Constitution may be reviewed and evaluated at the end of each academic year.
